

**GHOST HUNTERS REAL SCARY SWEEPSTAKES
2008 OFFICIAL RULES**

SWEEPSTAKES OPEN ONLY TO LEGAL RESIDENTS OF THE UNITED STATES (ALASKA, PUERTO RICO AND GUAM ARE EXCLUDED), WHO ARE 21 YEARS OF AGE OR OLDER AND RESIDE IN THE SERVICEABLE AREA OF A PARTICIPATING SYSTEM.

- 1. ELIGIBILITY:** These Sweepstakes are open to legal residents of the United States (Alaska, Puerto Rico and Guam are excluded), who are 21 years of age or older at time of entry and reside in the serviceable area of a participating cable system that is participating in these Sweepstakes (each, a “Participating System”). Decisions of the Sponsor are final on all matters relating to this Sweepstakes. Potential Grand Prize Winner(s) will be notified by phone, email and/or express mail on or about July 29, 2008 and will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release ("Release") except where prohibited by law. The Release must be received by Sponsor within five (5) days of Grand Prize Winner's receipt of the Release or prize may be forfeited and an alternate winner selected. Return of any prize notification as undeliverable will result in disqualification and selection of an alternate winner.
